I have been here at the Rea of Hope for a year now. Before coming here, I had lost everything I loved including myself. I was on the verge of losing my kids forever. That was my worst fear was to never see my babies again. I felt I was nothing without them. When I was younger and asked what I wanted to be when I grew up it was a mom. I had been in active addiction on and off most of my life. That was all I knew. I had tried treatment twice before and each time my head led me astray. I was lost, scared, and desperate. I wanted a better life for me and my kids. On November 28, 2018, I came to the Rea ready to try recovery again. This time I knew I had to do things completely different and I did. Something finally clicked and this program has saved my life. The love compassion and support I have been given here since walking through the door is truly amazing. Since being here I have regained custody of my kids.

I am able to tuck them into bed and say our prayers every night, take them to school every morning and show them the love they deserve every day. I have full time employment and have been there a year. I have paid off all my fines, obtained my license and purchased a car. My life today is full of love, happiness, and gratitude. Today because of the Rea of Hope and those who make it possible I have so much hope for our future. I can finally be the mother, daughter, sister, and friend God intended for me to be. I wanted to say thank you from the bottom of my heart for making this possible for me, my family and for so many other women.



## **REA OF HOPE SERVICE OVERVIEW**

Serving women in early recovery from alcohol and/or drug addiction is our primary goal. Rea of Hope believes all children deserve the best possible opportunities for a safe home like environment that nurtures them and provides opportunities. Many of our adult residents are children of addicts and alcoholics and come from a background of poverty and abuse that is multi-generational. ROH strives to make a difference in their lives and the lives of their children. We want to provide the best possible chance for another way of life. We work closely with the mothers, foster parents and child protective service workers to ensure the safety of the child and to help them reach their full potential. We address the most basic needs first, shelter and food. Next, we strive to educate, model and support changes in behavior and lifestyle that will support a safe and stable environment for these children and give them the opportunity to thrive rather than just survive. Rea of Hope is a proven and effective solution; we can help!!

#### **ADMISSION STATISTICS**

- 157 women screened for admission
- 23% of screenings admitted
- 97% bed occupancy
- 36 Rea of Hope admissions/15 New Life Apartment admissions
- Admission ages range from 19-58
- 84% of admissions are mothers
- 89% of admissions report a history of domestic violence and/or childhood abuse and/or sexual assault
- 89 % of admissions are homeless
- 100% of admissions are unemployed
- 18 WV counties served
- 31% of admissions report legal issues (parole, probation, drug court, pending charges)
- 31% of admissions had open CPS (Child Protective Services) cases

## **ACCOMPLISHMENTS**

- 18 successful Rea of Hope graduates/10 successful New Life graduates
- 50% success rate Rea of Hope / 67% success rate New Life
- 100% employment
- 100% of disabled residents complete a minimum of 25 community service hours' weekly
- 100% of residents pay their own program fees
- 2 grads currently attending college and 3 received GED
- 9 grads regained custody of their children
- Residents and graduates have celebrated over 900 months of sobriety!
   Services Provided

Annually, we are able to provide an average of 9726 shelter night for adults, 1652 shelter nights for children, 3640 sit down meals, and 9913 make your own breakfast and lunches. Referrals made for GED Preparation/Testing, Psychiatric Medication Management, Medical/Dental Health, Individual Counseling, Alcoholics and Narcotics Anonymous. Provided classes on Nutrition, Parenting, Credit Counseling, Public Transportation, Personal Responsibility, Work Etiquette, Personal Hygiene, Life Management Skills & Spirituality.

## **DOCUMENTED SUCCESSES**

In order to be considered a successful graduate, a resident must stay a minimum of six months, remain alcohol and drug free, maintain employment, attend AA/NA meetings and demonstrate personal responsibility.

We continue to follow all graduates at one moth, three months, six months and one year and document the following information:

Rea of Hope Outcomes based on 222 successful completions April 2005- December 31, 2019

One-year post- graduation (204 out of 222 meet this time frame)

78% Clean and Sober

85% Working

89% Living in a safe place

97% No new pending legal problems

75% Attending meetings

New Life Apartments Outcomes based on 76 successful completions December 31, 2019

One-year post- graduation (out 66 of 76 meet this time frame) (unable to contact 1)

91% Clean and Sober

100% No new pending legal problems
